Publication Agreement for the Submission of Electronic Theses Completed at the Medical Faculty of the University of Cologne

(hereinafter referred to as ZB MED)



The subject of this Agreement is the thesis ("Work") by the Author entitled:	

The Author hereby affirms that he/she is the sole owner of the copyright to his/her Work and that he/she has not conceded any rights or licences to publish this Work and its metadata that conflict with the rights granted under this Agreement. This also applies to texts, images and any other submissions supplied by the Author to which he/she holds the copyright. In the event that he/she offers ZB MED any texts, images or other submissions to which the above does not apply, he/she shall obtain the copyright/printing rights and append to the Agreement a written confirmation of having obtained these rights. He/she shall immediately notify ZB MED in writing of this and any other legally relevant fact of which he/she is or should be aware. In the case of works of joint authorship, the Author hereby affirms that the co-authors have granted him/her the sole right to approve the publication and exploitation of the Work. Should the Author subsequently become aware of any legal impediments that conflict with the performance of this Agreement, he/she shall immediately notify ZB MED.

#### § 2 Publishable works

§ 1 Subject of this Agreement

Publishable works are theses that have been declared to be ready for publication by the Dean of the Medical Faculty of the University of Cologne.

#### § 3 Services and obligations of ZB MED

- ZB MED hereby undertakes to store the Work and disseminate it via international data networks within the scope of its technical and organisational capabilities.
- 2. ZB MED shall maintain the integrity of the data in the event that any data migration is required. Based on current technologies, however, it is not possible to guarantee that the original page breaks will be maintained.
- 3. Within the scope of its technical capabilities, ZB MED shall take the necessary measures to ensure that the integrity of the content of the published Work is maintained in international data traffic.
- 4. ZB MED shall ensure that the Work is incorporated in local, regional and national catalogues.
- 5. ZB MED shall fulfil the requirements regarding legal deposit of the Work in digital format with the German National Library (DNB in its German



- abbreviation) in Frankfurt am Main and Leipzig, to the extent this is prescribed by law.
- 6. ZB MED undertakes to make appropriate reference to the fact that the Author holds the copyright to the Work.

### § 4 Granting and clarification of rights

- the Author grants ZB MED the non-exclusive right to reproduce and store the submitted electronic Work and the metadata of the Work on its own servers and/or those of its cooperation partners and to make the Work and metadata publicly available via international data networks.
- 2. ZB MED is entitled to forward the Work and metadata to third parties for the purpose of performing this Agreement as long as it maintains the integrity of the content of the Work and metadata. Examples of such third parties are digital preservation systems and the German National Library in Frankfurt am Main and Leipzig as part of maintaining the national published archive. The German National Library has the same entitlement as ZB MED to permanently store and disseminate the Work in accordance with its functions prescribed by statutory or administrative provisions.
- 3. ZB MED is entitled to produce a printed version of the Work at its own cost and to permanently archive this version in its holdings.
- 4. The Author hereby assigns ZB MED the right to migrate the data of his/her Work into other data formats should this become necessary due to technical developments and if this is the only way of continuing to safeguard the rights granted to ZB MED in paragraph 1. This right may be delegated to one of the institutions stipulated in paragraph 2.
- 5. The Author retains the right to dispose of his/her Work in other ways as long as this does not entail any restriction on the rights granted to ZB MED under this Agreement.
- 6. To enable academic citation of the Work, no changes whatsoever shall be made to the publication once it has been published, except for the changes in format stipulated in § 3 (2).

## § 5 Data transfer

The Author shall provide the full text to ZB MED in a publishable format as a PDF or PDF/A file, either on a data medium (CD-ROM, USB stick) or by email.



### § 6 Detailed requirements and conditions

- 1. Publication of theses requires the approval of the Medical Faculty in accordance with the provisions of the doctoral studies regulations. The declaration of consent must be given on this Agreement (see below).
- 2. In addition to the electronic version, it is also necessary to submit printed, bound copies of the thesis to the Dean's Office of the Medical Faculty. The number of copies to be provided is stipulated in the doctoral studies regulations.
- 3. The Author hereby affirms that the digital and printed versions of the thesis are identical in both their form and content (with the exception of the inclusion of personal data and the signature, which is not required in the online version). The doctoral advisor certifies that they have provided their consent for publication.
- 4. The Work shall be published once the ZB MED has received the digital version of the thesis and checked the Publication Agreement. Confirmation will also be sent to the Dean's Office of the University of Cologne's Medical Faculty.

#### § 7 Liability, claims for damages

- The Author hereby indemnifies ZB MED from any claims for damages for which he/she is responsible due to infringements of copyright, exploitation rights or any other third-party rights. This indemnity shall continue to apply even after termination of this Agreement. This duty of indemnification shall not arise if ZB MED has altered the submitted Work in a manner prohibited under this Agreement.
- 2. The Author is responsible for the contents of his/her published Work.
- 3. ZB MED cannot accept any liability for disruptions or faults in data networks or any changes that data may undergo during data transmission.

#### § 8 Contract term, termination

- The Agreement is concluded for an indefinite period. The right to terminate the Agreement giving statutory notice is hereby excluded, though the right to terminate the Agreement prematurely without notice for a compelling reason remains unaffected.
- Documents shall only be deleted in exceptional cases upon submission to ZB MED of a request from the Dean's Office of the University of Cologne's Medical Faculty.



Only the PDF full text shall be deleted – the corresponding set of metadata shall be preserved. ZB MED shall only delete the Work on its server and/or on the server run by its cooperation partner and shall submit a corresponding request for deletion to the German National Library. Due to the previous dissemination of the document on the Internet, it is not possible to delete any versions that have already been downloaded or disseminated in any other manner.

### § 9 Miscellaneous

- The Agreement is hereby concluded for an indefinite period. Any successor
  in title shall take on the respective rights and obligations of the parties
  concerned. Should one of the parties to this Agreement change, the other
  party shall have the right to terminate this Agreement with immediate
  effect.
- 2. If any provisions set out in this Agreement are held to be invalid or unenforceable in whole or in part, or if changes in legislation subsequent to the conclusion of this Agreement cause such provisions to become invalid or unenforceable, the validity of other provisions and of the Agreement as a whole shall not be affected.
