Data Retention:

Where necessary, we process and store your personal data only for the duration and administration of the fundraising campaign. In addition, statutory retention obligations apply. Data may therefore be retained for the duration of such statutory periods (for example, up to ten years under tax law) and will be deleted thereafter.
